Whereas McCaskill is a jobber focused solely on retail outlets, Johnny Robertson's company is a distributor that does not own or operate any retail stores. John's Fuel Services is a multibranded company with Citgo, Shell, and Sunoco branded outlets, as well as Liberty and PURE for unbranded business.
